**Sub: - Grant of fresh provisional affiliation to B.A. course for the session 2013-14.**

Dear Sir,

On the recommendation of the Inspector, Hon'ble Vice-Chancellor has been pleased to grant fresh provisional affiliation to the following courses in your college for the Session 2013-14 subject to fulfilment of the conditions mentioned as below:-

B.A. - (Hindi Lit., Sanskrit, History, Pol. Science, Urdu and Geography) with compulsory subjects - 80 Seats

### Conditions:-

I. To follow and observe the University Act, Statutes, Ordinances, Regulations, Rules and instructions framed, amended, adopted and issued from time to time in general and specifically relating to :-

- (i) Admissions of students in all the Courses.
- (ii) To follow curriculum courses of study as prescribed by the University from time to time including scheme of examinations and conduct of examinations.
- (iii) Appointment of Sports/ PTI/Library Staff.

II (i) STAFF:- Appointment of permanent and qualified Principal and Teaching Staff on the full time basis selected by a duly constituted Committee.

(ii) BUILDING :- Construction of sufficient building, play grounds and hostel building as per guidelines of the University within stipulated time.

(iii) LIBRARY:- Year-wise development of College Library and provision of funds for journals and magazines be made.

(iv) ENDOWMENT FUND:- sufficient endowment fund as prescribed in rules be created.

(v) FACULTY MEMBERS:- At least two faculty members in each subject be appointed as per the decision of the Academic council and Board of Management already circulated to Principals of all the affiliated colleges of the University.

III. (i) To provide the information as asked by the University from time to time including Statistics etc.

(ii) The College will abide by all the rules and regulations of University of Kota, Kota.

### Conditions as per inspection report:-

1. Principal and staff were not selected through duly constituted committee.

2. Qualified English lecturer is to be appointed.
3. College is not running in sufficient building. New building is required before start of next session.
4. Qualified P.T.I. is to be appointed.
5. List of management committee is not signed by competent authority.

It is required that the forwarded application for Extension in Provisional Affiliation, if not submitted earlier, should be sent through the Commissioner, College Education, Jaipur. Further, the satisfactory compliance report regarding the above mentioned conditions after removal of deficiencies should be submitted to the University at the earliest.
